Dear Neville,

Greetings from Hamilton Books! Your proposal was forwarded to me from Lexington Books, our sister press. I am interested in considering your manuscript for publication with Hamilton Books, but before your read further about the proposal review process, please take a moment to read the attached document which contains information about the Hamilton Books hybrid publishing model.

I typically review a proposal within the next 4-6 weeks of receiving the complete submission and then present it to our Editorial Board for consideration. You will be contacted in a few weeks with a decision about publication after all of the materials have been evaluated. In order for me to consider your proposal complete, I will require acknowledgement of the following important aspects of Hamilton Books' publishing program:

- 1. As part of our production process Hamilton offers professional typesetting. If your book is accepted for publication, you will need to prepare your final manuscript following the guidelines in our Author Handbook. Following these guidelines is essential to ensuring that your typeset book pages will meet your expectations. If you submit a final manuscript that does not meet our guidelines, we will require that you make any necessary revisions before we send your book into production.
- 2. Hamilton Books requires authors to place a prepublication purchase. The prepublication order quantity, format (paperback or hardcover) and list price for your book is dependent upon the nature of the project, the potential audience, and the page count. The prepublication order generally ranges between 50 and 300. The size of your prepublication order would be listed in your contract if we accept your book for publication, and the list price will be set based on the final page count of the manuscript. This purchase usually amounts to \$3,000-\$5,000. Please let me know whether or not you will be able to fulfill the prepublication order should your proposal be accepted.

Many of our authors, who use their books as textbooks in their classrooms, secure a prepublication order from their university bookstore. Authors of general interest titles will often set up speaking engagements or book signings at which they will sell their copies of their books, and they may also choose to use some of the copies to help generate additional publicity for the book. Finally, some authors choose to pay a subvention rather than purchase books; that generally costs less than the prepublication order would, but the author does not have books to sell at speaking engagements.

3. If you intend to include images in your manuscript, please note that images will appear in black-and-white in the print version of your manuscript and in color in the ebook version of your manuscript. Images will be capped at an amount that is deemed appropriate for the disciplinary scope and physical projected length of your book after the proposal review.

To move forward with a proposal review with Hamilton Books, please reply with the additional requested materials and acknowledgement of the pre-publication requirement.

If you would like to withdraw your proposal from review with Hamilton Books, please reply with "Please withdraw."
